## Model P: Registration of (managing) partner

### Why this Form?

This form is to have one or more partners of a public partnership (P.P.) or managing partners of limited public partners in the Commercial Register.

A partner can be a natural person, a company or a legal entity.

A maximum of three (3) partners can be listed with this form. If you want to list more, you will need additional forms.

### Problems?

- problems in completing this form, or
- in case you want to register a new public partnership (P.P. of L.P.P.) and no forms to do so were received.

In case you make a mistake while completing the form, simply strike through the wrong answer and write the correct one. Be sure to also add your signature to any changes!

### Why the Commercial Register?

Registration of companies and legal entities is mandatory under the Trade Register Ordinance. The information that you provide on this form will be entered into the Commercial Register.

The Register is public: other people will be able to retrieve your information and you may also retrieve information on other registrations, e.g. your potential trade partners. In this way the Commercial Register contributes to security in conducting business.

Information for the first registration of a business and other mandatory registrations must be submitted within one (1) week from the commencement of the business activities or, if applicable, from the date of the occurrence giving rise to mandatory.
